## VACANCIES

### Recruitment for Post of District Commissioner on Permanent basis

(For the Post of Deputy/Assistant Commissioner on Permanent and Contract basis)

Land Title Settlement Department will recruit Grade I Officers of the Sri Lanka Administrative Service for the existing vacancies for the post of District Commissioners in the District Offices established throughout the island on permanent basis and Grade II and III Officers in the Sri Lanka Administrative Service for the posts of Deputy / Assistant Commissioners for which the vacancies exist in Regional Offices on permanent basis and the retired officers of the Sri Lanka Administrative Service on contract basis.

#### 1. Post - DISTRICT COMMISSIONER (Permanent Basis)

I. Qualification - Being a Grade I Officer of the Sri Lanka Administrative Service

#### 2. Post - DEPUTY / ASSISTANT COMMISSIONER (Permanent Basis)

I. Qualification - Being a Grade II or III Officer of the Sri Lanka Administrative Service

#### 3. Post - ASSISTANT COMMISSIONER (On Contract Basis)

- I. Qualification - Being an Officer of the Sri Lanka Administrative Service
- Being a person who had retired formally from the government service
  - Should not have been subjected to disciplinary inquiries during the service period
  - Should be between 60 - 67 years
  - Should be physically and mentally fit and should submit a recent Medical Certificate to prove the fitness for service at the interview.

#### II. Method of Selection

- Qualified officers according to the recommendation of the Interview Board will be selected

#### III. Allowances and other facilities

- Allowances and other benefits will be granted according to Public Administration Circular No. 03/2018.

#### Method of Applying:

Officers in service anticipating to apply should direct their applications through the Heads of their Institutions and the retired officers should self prepare a Bio-Data and send by registered post to the address given below to receive before 30.09.2020. Late applications will be rejected. Application for the Post for which the vacancy exists should be mentioned on the left hand top corner of the envelope containing the application.
