Applications are invited from Sri Lankan applicants to fill the following vacancies of the Sri Lanka Ayurvedic Drugs Corporation.



01. GENERAL MANAGER

Senior Management Services
Category (HM 2-1) – 01 Vacancy

Salary Scale :

HM 2-1 – 91,645 – 12 x 2700 – 124,045/= (Entitled from 01.01.2020 as per Management Services Circular 02/2016. Government approved allowances and allowances given by the Corporation will also be offered. Starting salary to the date (01.01.2020) is Rs. 93,020/=.

Qualifications:

External Applicants -

Should be not less than 35 years and not more than 55 years. Maximum age limit will not be applicable to internal applicants.

Qualifications :

External Applicants -

Should have obtained a degree in Commerce / Marketing / Economics / Business Management / State Management / Business Administration from a University accepted by the University Grants Commission.

and

Minimum of 03 years experience in a Staff Level relevant Post in a Government or semi-government or state institution or in a reputed private sector institute relevant to the field of supplies or procurement, after obtaining the Degree.

Internal Applicants – (01 or 02 below)

01. Should have fulfilled the above qualifications for external applicants.
02. Should have completed minimum of 05 years satisfactory service period in the relevant field, in the Junior Management Service (JM 1-1) Category.

Age :

Should be not less than 22 years and not more than 45 years. Maximum age limit will not be applicable to internal applicants.

Qualifications :

External Applicants – (01 or 02 below)

01. Ayurvedic Medicine and Surgery Degree accepted by the University Grants Commission,

and

Should have obtained minimum of 03 years experience in a government or semi-government or in a reputed private sector organization in the category of Staff Level in the field of drugs manufacturing.

02. Should have obtained a 05 year Diploma from a Universities affiliated, accepted medical institute and 03 years experience in a Staff Level position of drugs manufacturing field (in a drugs manufactory) in a government or semi-government organization or in a private sector organization.

01. Should have fulfilled the above qualifications for external applicants.

02. Should have obtained a proficiency certificate of not less (NVQ) Level 07 from a Technical/ Professional Training Institute accepted by the Tertiary / Professional Education Commission.

Minimum of 03 years experience in a Staff Level Post in a Government or semi-government or state institution or in a reputed private sector manufactory relevant to the field, after obtaining this qualification.

Qualifications :

External Applicants – (Compulsory General Qualifications)

- a) G.C.E. (Ordinary Level) Examination
Should have passed six (6) subjects with credits for four (4) subjects including:
- Sinhala / Tamil
 - Mathematics
 - English Language (if required, according the role of duty)
- b) Should have passed three (3) subjects (except Common General Test) in G.C.E. (A/L) Examination.

And

(Having followed a Course of Word Processing / Typewriting, accepted by Tertiary & Vocational Education Commission or equal eligibilities can be produced as qualifications, whenever necessary).

Should have 01 year experience in a reputed institution.

Note :

A period of training in which a person has served or was employed as a condition of appointment before being permanently appointed to a certain post is not counted for the five year period of employment to qualify for the required qualification as mentioned in the above para 'c'. Any temporary /casual service period before confirmation in the permanent appointment will not be counted to qualify as mentioned in the above para 'c'.

Age :

Should be not less than 18 years and not more than 45 years. Maximum age limit will not be applicable to internal applicants.

Other :

Common for all applicants.

- Should be a citizen of Sri Lanka.
- Should be prepared to fulfill duties entrusted efficiently and to serve in any part of the country and in good physical and mental condition.
- Should be with excellent character.

Method of Recruitment :

Recruitments will be made through a structured interview by a Board appointed by the Officer authorized for appointments, as per the recruitment procedures of the Corporation.

Employee will contribute 8% of the salary and 12% by the employer to the Employees Provident Fund and further 3% to the Employees Trust Fund by the employer.

Applicants in the employment of government departments, state corporations and statutory boards should submit their applications through their respective Heads of the Departments. Fully completed bio-data with certified copies of certificates should have been attached to the application. Applications not attached with certified copies of certificates will be rejected.
