#### 1. General Qualifications required:

- 1:1 Every applicant must furnish satisfactory proof that he is a Sri Lankan. A "Sri Lankan" is a citizen of Sri Lanka by descent or by registration as defined in the Sri Lanka Citizenship Act.
- 1:2 A candidate for any post for which the minimum educational qualification prescribed is a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass in the Senior School Certificate Examination or equivalent or higher examination, should have a pass either in Sinhala language or Tamil language obtained, as the case may be, at the Senior School Certificate Examination or its equivalent if he is either a Sinhalese educated in Sinhala Medium or if he is a Tamil educated in Tamil Medium (This requirement will not apply to those who are in the public service from a date prior to January 01,1961, and who seek appointments to other posts in the public service).
- 1:3 Application from the "New Entrants" Public Officers, who are not either Sinhala or Tamil educated, whose probationary trial appointments have been terminated for failure to pass the prescribed official language proficiency tests will not be entertained unless they have obtained the qualifications which could entitle them to seek exemptions from the highest proficiency test prescribed for the post.

#### 2. Conditions of Service-General:

- 2:1 All officers in the Public Service will be subject to the Financial Regulations, the Establishments Code, Departmental Orders or Regulations and any other Orders or Regulations that may be issued by the Governments from time to time.
- 2:2 A Public officer may be required to furnish security in terms of the Public Officers (Security) Ordinance, in such sum and in such manner as the secretary to the Ministry concerned may determine.
- 2:3 A Public Officer may be called upon to serve in any part of the Island.

### 3. Conditions of Service applicable to Public Officers holding permanent appointments :

- 3:1 In addition to the conditions referred to in Section 2 above Public Officer holding permanent appointments will be subject to the following further conditions:
- 3:1:1 All appointments will be on probation for a period of 3 years unless a longer period is considered necessary in respect of any post. Any appointment may be terminated at any time during the period of probation without a reason being assigned.
- 3:1:2 All public officers are required to conform to the provisions of the Chapter IV of the Constitution of the Democratic Socialist Republic of Sri Lanka and any other laws, regulations or rules that may be made from time to time to give effect to the Language Policy of the Government.
- 3:1:3 All Public officers who have not entered the Public Service either in Sinhala Medium or in Tamil Medium are required to acquire a working knowledge in one of the official languages.
- 3:1:4 Confirmation at the expiry of the period of probation of an officer who entered the Public Service in a medium other than Sinhala or Tamil will depend, inter alia, on the passing of the Grade 1 Proficiency Test in one of the Official Languages within one year; Grade II Proficiency Test within two years, and Grade III Proficiency Test (where applicable) within three years from the date of appointment.

Faliure to pass a test within the prescribed period will result in the suspension of increments. Suspension will be converted to a stoppage if the test is not passed within a further period of six months beyond the prescribed period such stoppage operating until the test is passed or until such time as the provisions of Section 3:1:6 below apply.

- 3:1:5 Such officers should, on receiving appointment, be given facilities on full pay, for a period of 6 months to obtain proficiency in one of the official languages. He will thereafter, be required to sit the relevant proficiency examination and if he does not pass he will be given the opportunity to pass the examination within a period of 2 years immediately after the period of 6 months on full pay, while he performs his normal duties.
- 3:1:6 If he fails to pass the examination in this prescribed period of 2 1/2 years his services will be terminated.
- 3:1:7 A Public Officer already confirmed in permanent post in the Public Service will not normally be required to serve the period of probation on being appointed to another permanent post in the Public Service. Such

Officers may in the first instance be appointed to act in the new post for a specified period with a view to testing him in his new post.

3:1:8 Selected candidates (Other than those already holding permanent or temporary appointments in the Public Service) who have already been medically examined will be required to undergo a medical examination by a Government Medical Officer to test their physical fitness to serve in any part of the Island.

#### 4. Terms of Engagement :

- 4:1 Public officers appointed to permanent and pensionable posts should contribute to the 'Widows and Orphans' Pension Scheme from their salary an amount equivalent to the percentage the Government requires to recover from their salary.
- 4:2 Public officers appointed to permanent or temporary posts on Provident Fund basis will be required to contribute 6% of their consolidated salary to the Public Service Provident Fund. The Government will contribute as its share of contributions an amount equal to 150% of the compulsory contributions credited to the fund at the close of the Financial Vear
- 4:3 Officers who hold pensionable appointments in the Public Service and who are released for appointments to pensionable posts in the Local Government Service and those officers in the Local Government Service who hold pensionable appointments and who are released for appointments to pensionable posts in the Public Service will be allowed pensionability in their posts in the Local Government Service and Public Service respectively.
- 4:4 Regular Force personnel in the Army, Navy and Air Force who are released for appointments to posts in the Public Service which are pensionable under the Minutes on Pension will be allowed pensionability in their posts in the Public Service. Notwithstanding anything to the contrary in these Minutes the unforefeited full pay service of any member of the Armed Forces who is released to accept an appointment as a Public Officer in a post which has been declared to be pensionable under these Minutes shall be reckoned for the purpose of any pension or gratuity payable under these Minutes.

#### 5. Serving Officers in the Public Service :

- 5:1 Applications from officers of the Public Service who possess all the necessary qualifications must be forwarded through the Heads of their respective Departments. In the case of applications from Public Officers holding post in the permanent establishment in the Public Service. Heads of Departments in forwarding such applications should state whether the applicants could be released or not to take up the new appointment, if selected.
- 5:2 Candidates may be required to present themselves for interview at an appointed time and place. No travelling or other expenses will be paid in this connection.
- 5 :3 Anyone desiring to recommended a candidate should do so by giving a testimonial. Any form of canvassing or any attempt to influence the selection of a candidate will disqualify such candidates.
- 5:4 Any statement in the application which is found to be incorrect will render the applicant liable to disqualification if the inaccuracy is discovered before the selection and to dismissal if discovered after the selection.
- 5:5 Application not conforming in every respect with the requirements of the advertisement will be rejected.

#### 6. Definition of Salary for the purpose of Eligibility:

 $6\,:\!1$  Salary for purposes of eligibility means only the consolidated salary and does not include any action salary, allowances etc.

#### $7. \ New \ National \ Policy \ on \ Recruitment \ and \ Promotions:$

Recruitment and Promotion in the Public Service, Provincial Public Service, Public Corporate Sector and Companies fully owned by the Government will be done in accordance with the policy laid down in the Public Administration Circulars No. 15/90 of 09.03.1990, 15/90 (I) of 25.03.1990 & 15/90 (ii) of 15.06.1990 with effect from 01.01.1990 subject to amendments that will be done by subsequent Public Administration Circulars.

#### RULES AND INSTRUCTIONS FOR EXAMINATION CANDIDATES

All examination candidates are bound to act in compliance with the provisions of the Public Examinations Act, No.25 of 1968 which was amended by No.19 of 1976 and other rules and regulations imposed from time to time.

The following conditions and restrictions are hereby imposed through the Sentence No. 20 of the Public Examinations Act, No.25 of 1968 which was amended through No.19 of 1976 as per the powers assigned to the Commissioner General Examinations.

All examination candidates are bound to abide by the rules given below and a candidate who violates any of these rules is liable to one or more of the following penalties mentioned below at the discretion of the Commissioner General of Examinations.

- Debarring to appear for the whole examination or part of it which was under investigation.
- Disqualifying from one subject or from the whole examination which was under investigation.
- III. Imposing lifetime ban for all the examinations conducted by the Department of Examinations, Sri Lanka.
- IV. Debarment from appearing for examinations conducted by the Department of Examinations, Sri Lanka for a certain period of time.
- V. Issuing a letter with suspended debarment of examination.
- VI. Suspension of the certificate for a specific period
- VII. Handing over the examination candidate to the police to file a criminal case under the Public Examinations Act or complaining the police regarding such act.
- VIII. When the examination candidate is a government employee, reporting the appointing authority of such examination candidate (to take disciplinary actions) regarding the conduct of such examination candidate.

The Commissioner General of Examinations reserves himself the right to take actions with respect to such examination candidate prior to, during or after the examination or at any stage. His decision with respect to that should be deemed final.

- 1. Every examination candidate should act in the examination hall and at the examination premises in such a manner that any disturbance or obstruction should not take place for the examination supervisor and his staff as well as for other examination candidates. Moreover, examination candidates should not vandalize the property of the examination premises or damage the private property of the examination staff.
- 2. Examination candidates should act in compliance with the instructions given by the examination supervisor and his staff when the examination is in progress and before the commencement of the examination as well as immediately after the end of the examination.
- 3. No examination candidate will be admitted to the examination hall after the lapse of half an hour subsequent to the commencement of the question paper at an examination. Also, no examination candidate will be permitted to leave the examination hall until the examination ends. Actions should be taken to participate for practical tests or oral tests on time.
- 4. Every examination candidate should sit on the seat reserved for him/her bearing the respective Index Number and not any other seat. Unless with the special permission of the examination supervisor, no candidate should change his/her seat. The occupation of a seat other than the one assigned to him/her is liable to be considered as an act committed with dishonest intention.
- 5. Absolute silence should be maintained in the examination hall. A candidate is forbidden to speak to or to exchange messages or to have any dealing with any person within or outside the examination hall for any matter other than a member of the examination hall staff.
- 6. Since the answer script of an examination candidate will be solely identified through the candidate's Index Number, it is completely prohibited to write one's name on the answer script, put a certain mark or note to distinguish the answer script, write indecent or unnecessary things on the answer script and attaching currency notes with the answer script. Further, writing other examination candidate's Index Number on one's answer script could be considered as an attempt to commit a dishonest act. Answer scripts bearing Index Numbers those are difficult to decipher are liable to be rejected.
- 7. Examination candidates should not write on question paper or desk or any other place except on the papers (papers given to answer with the invigilator's short signature and the date with regard to the day on which the examination is conducted) supplied at the examination hall. Acting non-compliance with these instructions will be considered as an act committed with dishonest intention.
- 8. Any paper or answer books supplied to examination candidates should not be torn up or crushed. Each and every sheet of paper used for rough work should be clearly crossed out and attached to the answer script or submitted with the answer script at the end of the examination or the candidate should do the needful as per the given instructions. It is forbidden to take out anything written inside the examination hall. If a question has been answered twice in two different places, the unnecessary answer should be clearly crossed out.
- 9. It is forbidden to take out the papers or any other material supplied to answer at the examination out of the examination hall. All such materials are belonged to the Commissioner General of Examinations and breach of this rule will be considered as a punishable act.
- 10. When examination candidates appear for the examination in the examination hall, they should not keep in their possession or by their side other note books, papers with notes or paper pieces except the stationery supplied to them for answering at the examination and the materials which were authorized in written for each examination. Also, keeping mobile phones, electronic communication instruments/ devices in one's possession or by one's side and obtaining assistance from external parties through such instruments/devices and sending information to other parties and social media while the examination is in progress are considered to be dishonest acts and punishable offences.
- 11. In case electronic communication instruments/devices are revealed to be used for the purposes mentioned in the above paragraph no. 10, such instruments/devices will be taken into the custody of the Commissioner General of Examinations until the investigations are concluded.
- 12. After sitting in the examination hall, an examination candidate is strictly forbidden to keep any unauthorized material or instrument in his/her possession prior to the examination or when the examination is in progress. In case the supervisor or the examination orders, each candidate is bound to declare everything he/she has with him/her and get them

checked. Breach of these requirements should be considered as an attempt to commit an act of dishonesty.

- 13. It is an offence, in case a candidate copies or attempts to copy from the answer script of another candidate or a book or a script or a paper containing notes or through signals or any other source or acts dishonesty. Also, helping another candidate and getting help from another candidate or a person or exam staff are also offences and every completed answer sheet should be kept underneath the sheet on which the answer is being written. Writing papers should not be strewn all over the desk.
- 14. A candidate will under no circumstance whatsoever be allowed to leave the examination hall even for a brief period during the course of the paper after the commencement of the examination. However, in case an examination candidate needs to leave the examination hall to use the lavatory/urinal, the candidate will be permitted to go outside for a brief period under the surveillance of an officer belongs to the assistant staff of the examination supervisor. He/ She shall be subject to search before leaving the examination hall as well as when re-entering it.
- 15. Impersonation before commencement of answering at the examination hall or after, is a punishable act. Tampering with identity cards or presenting false identity cards is considered to be an act of dishonesty.
- 16. Assistance given to a candidate in an improper and dishonest manner by a candidate or a person, who is not a candidate, is considered to be a serious offence.
  - 17. Examination candidate should adhere to the following instructions.
    - I. Every examination candidate should take actions to get the signature in their admission paper attested and get the subjects amended prior to the examination, after inquiring the Department of Examinations, Sri Lanka in case there is any discrepancy between the subjects applied and the subject indicated in the admission paper.
    - II. It is appropriate to arrive the examination hall, half an hour prior to the commencement of the examination and if you are not quite certain of the location of the examination hall, make inquiries on a day prior to the date of examination and be sure of its exact location.
    - III. Candidate should produce their identity cards and get their identities confirmed at every paper they sit when appearing for the examination.
      - (a) Actions will be taken to cancel the candidature in case a candidate fails to produce the identification documents at the examination hall and in case a candidate forgets to bring such documents into the examination hall, that fact should be brought to the notice of the supervisor and arrangements should be made to produce them before the examination ends.
      - (b) Every candidate should be in the examination hall during the examination period in such a way that his/her face should be clearly recognizable to display his / her identity in a clearly visible manner.
    - IV. Examination candidates should keep their ears openly and in a clearly visible manner so as to confirm that they are not using electronic communication instruments/ devices like Bluetooth.
    - V. No paper other than those issued at the examination hall should be used for answering questions. Excess paper and other materials should be left on your desk in good condition in a reusable manner.
    - VI. Examination candidates should bring their own pens, pencils, erasers, foot rulers, geometrical instruments, boxes of coloured pencils and boxes of coloured chalks,etc.
    - VII. When you start answering, you should promptly write down the Index Number clearly on the answer book used and each sheet of paper. Write answers clearly and legibly on both sides of the paper. You should leave at least a single blank line after providing the answer to a part of a question before starting to answer the next part of such question. You should provide answers in a fresh page for each question.
    - VIII. The left-hand margin of the answer sheet is set apart to enter the question number. Since the right-hand margin is reserved for the examiner's use, nothing should be written there. Actions should be taken to number the questions you answered correctly as incorrect numbering leads to confusion.
    - IX. When mathematical questions are answered, give all details of calculations and any rough work in their serial order as part of the solving of the sum. The sketches and diagrams drawn in the relevant places should be accurate and sufficiently large.
    - X. You should read carefully the instructions given at the head of the questions paper with regard to the compulsory questions and the other questions which should be selected. Marks will not be granted for answers provided disregarding the given instructions in the question paper.
    - XI. At the end of answering for each question, in addition to the answer book used, the answer sheets should be collected according to the page number and then should be tied/attached at the top left-hand corner in a non-detachable manner. Make sure whether you have attached all the answer sheets prior to handing over the answer script. Any answer sheet taken out of the examination centre will not be evaluated after the handing over of such answer scripts.
    - XII. Your answer script should be handed over to the examination supervisor or to an officer of his/her staff. You should remain in your seat until the answer scripts are collected. Failure to do so may result in the loss of your answer script and your being treated as an absentee for a certain subject.
    - XIII. If it becomes necessary for you to speak to the examination supervisor or an officer of his/her staff due to a certain matter, you should sign him by tapping two times on the desk without disturbing others.

#### MINISTRY OF EDUCATION

Admission of Student Teachers to National Colleges of Education to follow a three year Pre-Service National Diploma in Teaching Course based on G.C.E. (A/L) results in 2018 – 2020

- 1.0 APPLICATIONS are invited from the applicants who have acquired requisite academic qualifications and eligibility to follow a three year Pre-service National Diploma in Teaching Course in a National College of Education.
  - 1.1. This is relevant only for the students who have passed the G.C.E. (A/L) Examination in the year 2018. (Clauses 4.5 and 4.8 are relevant for the courses of Buddhism, Catholicism/ Christianity)
  - 1.2. All the applicants should forward the application online in accordance with instructions mentioned in Chapter10.0 'Instructions for Applying' of the *Gazette* Notification.
  - 1.3. Application should be forwarded on or before 25.09.2020.
  - 1.4. It is the responsibility of the applicant to read and understand every detail provided in the *Gazette* Notification under the courses s/he applies for, and complete the application accordingly.
  - 1.5. Special attention should be paid to the number of applicants recruited for each course as mentioned in the tables under 14.1, 14.2, 14.3 and 14.4 relevant to clause 14.0 in the *Gazette* Notification before completing the application.

#### 2.0 Eligibility:

Every applicant should be –

- 2.1 a citizen of Sri Lanka.
- 2.2 of an excellent character and sound physical and mental health.
- 2.3 Age:
  - 2.3.1 Should be not more than 25 years of age as on 01.01.2020;
  - 2.3.2 Clergy/those who bear priesthood should apply only for the relevant religious courses; and those applicants should

be not more than 30 years of age as on 01.01.2020.

2.4 Should be unmarried.

#### 3.0 Basic Educational Qualifications:

- 3.1 3.1.1. It is compulsory that all the applicants except those who apply for Buddhism course should have completed the basic educational qualifications in 3.2 and 3.3.1 mentioned below for applying for the admission to National Colleges of Education.
  - 3.1.2. Only when applying for the Buddhism course, together with qualifications in 3.2 one of the qualifications mentioned in 3.3.1 or 3.3.2 should have been completed.
- 3.2 Should have passed in three (03) main subjects in one sitting at the G.C.E. (A/L) Examination held in the year 2018.
- 3.3 3.3.1. The applicants should have passed in six (06) subjects including Medium Language (Sinhala Language/Tamil Language) and Mathematics with credit passes for three (03) of those subjects at the G.C.E. (O/L) Examination. If these qualifications are completed in two attempts it is compulsory to pass in five (05) subjects including Medium Language (Sinhala Language/Tamil Language) with three (3) credit passes in the first attempt.
  - 3.3.2. Should have passed in six (06) subjects including Mathematics and Sinhala Language with three (03) Credit passes in not more than two sittings at Preliminary Pirivena Final Examination.
- 3.4 The applicants who have completed the basic qualifications mentioned in 3.2 and 3.3 above should have completed the specific qualifications of G.C.E. (O/L) necessary for each course in not more than three sittings.
- 3.5 The specific qualifications required for each course are specified under the relevant course.

**NOTE:** Following subjects are considered under the G.C.E. (O/L) syllabus:

- 1. Core (Main) Subjects:
  - (i) Religion
  - (ii) Sinhala Language and Literature / Tamil Language and Literature
  - (iii) English Language
  - (iv) Mathematics

- 2. Category Subjects:
  - (i) any subject out of first category of subjects
  - (ii) any subject out of second category
- (iii) any subject out of third category.

Subjects considered under Preliminary Pirivena Final Examination:

- (i) Sinhala (ii) Pali (iii) Sanskrit
- (iv) English (v) Mathematics (vi) Thripitaka
- 3.6 The applicants who apply for the courses conducted in the medium of English should have achieved English language proficiency as follows.
  - 3.6.1 Those who apply for English medium courses except for English Language Course should have obtained minimum of a credit pass in English Language / ordinary pass in English Literature at the G.C.E. (O/L) Examination.
  - 3.6.2 Although the Western Music course is conducted in the English Medium, the applicants who followed G.C.E. (A/L) in other mediums of instructions also may apply.
  - 3.6.3 Only the applicants who are capable of following the courses in the medium of English should apply for this because all the Teaching Activities and Examinations are conducted in English medium.
- **3.7** Applicants who are called for interview for Art/ Dance (Oriental)/Dance (Bharatha)/ Music (Oriental) /Music (Carnatic) /Drama and Theatre will be graded and selected as mentioned below.

- While applicants will be called for the interview on the district basis according to their Z-score order the selection will be made on the priority order of district basis in accordance with the descending order of the grade obtained for the relevant Aesthetic subject in G.C.E. (A/L) Examination, matching with their Z-score order. Accordingly, the applicants who have obtained higher Z score with the highest grade for the relevant Aesthetic subject will be given priority on district basis.
- 3.8 Effective date of all the Educational and Other Certificates should be on or before the closing date of applying (25. 09. 2020).

#### 4.0 Qualifications for each Course:

It is important that your special attention is paid to the following points.

#### **NOTE:**

- 3.2 and 3.3 of 3.0 above indicate the minimum basic educational qualifications that should be completed at G.C.E. (A/L) and (O/L) Examinations, Preliminary Pirivena Final Examination for applying for the admission to National Colleges Education. In addition, the subject proficiencies that should specifically be achieved for the courses are indicated under each course.
- The applicants are called for the interview on the order of marks obtained by applicants for sports for the Health and Physical Education course; in accordance with the clauses mentioned in the *Gazette* Notification for English, Information & Communication Technology and other courses with a specified quota; and in accordance with the order of Z-score of the applicants relevant to the procedures as mentioned in the *Gazette* notification for all the other courses.
- In a particular course, in case a quota (a percentage) has been allocated for different qualifications (except for Catholicism / Christianity), the number of applicants allocated for the quota out of the total number of admissions in a specific district for that course is called for the interview and selected.

### 6.0. Procedure for Selection of Student Teachers for year 2020:

#### 6.1 Basis of Selection:

- 6.1.1. The number of student teachers to be admitted to the colleges has been decided by considering the teacher carder requirements based on the number of vacancies created through the retirement of teachers in the year 2023, the existing number of vacancies at present in the school system and the necessity of making subject variations in the under-privileged areas and calculating the teacher requirement for each subject and matching that number to the available facilities for each subject in 2020 at National Colleges of Education simultaneously.
  - A higher percentage of student recruitment for the courses of Primary Education, Science, Mathematics and English will be allocated for the under-privileged districts of Nuwara-eliya, Hambanthota, Jaffna, Kilinochchi, Mannar, Vavuniya, Mulaithivu, Batticaloa, Ampara, Trincomalee, Puttlam, Anuradhapura, Polonnuruwa, Badulla, Monaragala and Ratnapura.
  - The major determinant for the number recruited for each subject is the number that can be facilitated

### by the National Colleges of Education for each subject.

- 6.1.1.1. Accordingly, the recruitment in 2020 will be made as mentioned below for the candidates who passed G.C.E (A/L) in 2018.
  - (I) The number mentioned in the Gazette to be recruited from each district for each course (except for physical Education course) from each medium will be recruited following the Note 4.0 and the methods indicated under the relevant courses considering the order of Z score the candidates have obtained in each district and other qualifications mentioned in the Gazette notification. The number recruited for the subject of Physical Education from each district under each medium will be decided according to the order of marks for sports obtained by each candidate as indicated in 4.0 and under the relevant course.
  - (II) The number mentioned in the *Gazette* to be recruited from plantation districts to Sripada National College of Education for each course from each medium will be selected following the Note 4.0 under the special conditions mentioned in the *Gazette* notification, other qualifications with the order of Z score the candidates have obtained in each district.

6.1.2 When the selections are made on the basis of Z-score, if one student should be selected out of several students who have obtained the same Z-score in the relevant district / considering the Performance of sports marks if one student should be selected out of several who have scored the same mark, the results obtained in six (06) score (main) subjects indicated in 3.5 of 3.0 at the G.C.E. (O/L) examination at the first sitting will be considered.

Accordingly, marks will be awarded as 04 marks for a Distinction Pass, 03 marks for a Very Good Pass, 02 marks for a Credit Pass, and 01 mark for an Ordinary Pass at the G.C.E. (O/L) results and the available number of vacancies will be filled based on the total marks obtained.

- 6.1.3 Applicants of Physical Education, Dance (Oriental), Dance (Baratha), Music (Oriental), Music (Carnatic), Drama and Theater and Western Music courses should reach a satisfactory level of performance at the Practical Test conducted for the subject applied.
- 6.1.4 When the selections are made on district basis, if the required number of qualified applicants for a particular course is not available in the total database, the provincial performance of the applicants of the relevant province to which the particular district belongs to will be considered. If there are not enough candidates in the province to which the particular district belongs to, the national level performance of the candidates will be considered.

#### 6.2 Determination of Permanent Residence:

- 6.2.1. District/Province of permanent residence of applicants will be determined as mentioned below.
  - 6.2.1.1. In the district basis recruitment, the applicant's district should be the district in which the applicant resided in the year when s/he appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that.
  - 6.2.1.2. It is emphasized that if the candidate has changed his/her district of

permanent residence by present/has resided temporarily in the district for personal convenience/it is not the district of permanent residence of the candidate though it is the district where the candidate appeared for the G.C.E. (A/L) Examination at the first sitting or after that, the particular district will not be considered as the district of permanent residence.

- 6.2.1.3. The province in which the applicant permanently resided in the year s/he appeared for the G.C.E. (A/L) Examination in the first sitting and the two years immediately preceding to that will be considered as the province of the applicant in determining the province.
- 6.2.2. Every applicant should confirm his/her permanent residence subjected to the ways mentioned below.
- NOTE: No applicant is required to attach any document relevant to permanent residence to applications because data of electoral registers will be checked online with the approval of the elections commission during the interview.
  - I. Applicants should confirm their permanent residence by the data of electoral registers as per the basis of recruitment.
- II. In case of the years of which the applicant was unable to register in the electoral register due to being underage, permanent residence of the applicant in such years should be confirmed by the data of electoral registers in which the names of the applicant's parents appear.
- III. Applicants who resided with a guardian other than the parents during the concerned period of time should confirm permanent residence at the interview by including such guardianship with the period of time, under the column 'Other Information' in the 'Certificate of Residence and Character' issued by the Grama Niladhari (DS 04). In case of the years of which the applicant was unable to register in the electoral register, permanent residence of the applicant in such years should be confirmed by the

data of electoral registers in which the names of the applicant's guardian appear.

- IV. In case that the applicant fails to confirm their permanent residence of three years or several of the years by the data of electoral registers due to the candidate being unable to register in the electorate, acceptable reasons should be provided for being unable to register in the electorate at the interview in the 'Certificate of Residence and Character' issued by the Grama Niladhari (DS 04) under the column 'Other Information' with the signature of the Grama Niladhari of the division where the applicant's permanent residence is/was during the period concerned and counter signed by the Divisional Secretary.
- V. In case that the applicant is able to confirm permanent residence only of one or two years through data of electoral registers due to non-registration, permanent residence of the remaining year/years should be confirmed by other acceptable documents (e.g. Certificate issued by the Grama Niladhari, address in the National identity card issued by the department of Registration of Persons).

### 6.3. Selection for Sripada National College of Education:

- 6.3.1. Vacancies will be filled as per the ratio of 75% out of the applicants of the Indian Tamil origin and 25% out of Sinhalese applicants. (Indian Tamil candidates should be able to prove their nationality at the interview with direct or secondary evidence and the nationality of their mother/father should appear as "Indian Tamil" in the birth certificate of the candidate.)
- 6.3.2. The number of applicants recruited will be allocated to plantation districts based on the available number of vacancies in those districts
- 6.3.3. Applications for admission to Sripada National College of Education will be entertained only from the children whose parents are estate workers and residents in plantation districts; Nuwara Eliya, Kandy, Matale, Badulla, Moneragala, Ratnapura, Kegalle, Kalutara, Matara, Galle, Kurunegala and Colombo.

- 6.3.4. Priority will be given to children of the workers who work in estate sector at present and the children of estate workers living in estates after serving for at least 10 years in the estate sector and retired/left service on medical reasons/ passed away during 2009 2018.
- 6.3.5. In case of insufficient number of applicants as per the clause 6.3.4 above, applications from the children of the estate workers who fulfill the following qualifications will be considered even if they are not employed in the estate sector at the moment.
  - 6.3.5.1. Children of plantation workers those who worked continuously at least for 05, 04, 03 years, by 2008 or after that will be considered respectively. (Priority is given respectively as 2017, 2016, 2015).
- 6.3.6. In case of insufficient number of applicants qualified in Tamil Medium as mentioned above, applicants those who are not the children of employees in the plantation sector, but of Indian Tamil origin living in those districts will be considered.
- 6.3.7 In case of insufficiency of qualified applicants under the above category too, Tamil Medium applicants with Indian Tamil origin who are residing in other districts will be considered.
- 6.3.8. 6.3.8.1 In case of insufficient number of Sinhala Medium applicants from estate workers' children of plantation districts, the rest of the vacancies will be filled out of those who have applied for the same course in Sripada/ Other National Colleges of Education. The procedure of the selection will be the Z-score and the other required qualifications under the basis of recruitment.
  - 6.3.8.2 In case of insufficient number of Tamil Medium qualified applicants according to 6.3.4 6.3.7, the rest of the vacancies

will be filled out of the qualified applicants in the data base for other National Colleges of Education where the Tamil Medium interviews for the same course are conducted.

- 6.3.9. At the interview, the children of the employees in the state and private sector estate companies should submit relevant documents out of the documents mentioned below to confirm that they are children of estate workers.
  - The letter certified by the Estate superintendent relating to current service (with relevant time duration) that the parent is permanently and continuously serving and residing in estates.
  - The letter certified by the Estate superintendent confirming the current permanent residence of the family members of estate workers those who have resigned from service due to medical reasons/ retired/passed away during 2009 2018 after serving in estate sector for 10 years. Permanent residence in the estate at present and the year and date of retirement/ resignation should be clearly mentioned in the letter and the Grama Niladhari certificate.
  - The letter certified by the Estate Superintendent confirming the continuous service for the relevant period of 05 years or more in plantation sector workers who retired/resigned in or after 2009 indicating year and date of the retirement/ resignation clearly.
  - Letter/s including Registration Numbers to prove that deductions are being/ have been made for the Employees' Provident fund. The certificate issued by the Grama Niladhari confirming the residence in estates.
- 6.3.10. Applicants should submit an affidavit at the interview declaring that she/he will serve

- a period of ten (10) years continuously in the schools in the plantation sector after the course.
- 6.3.11 In the case of an applicant having an Indian Tamil origin who had studied in Sinhala Medium, they will be considered for the percentage entitled to Indian Tamil origin. Similarly, a Sinhalese applicant who had studied in Tamil Medium will be considered for the Sinhala Medium percentage.
- 6.3.12 Children of estate workers who apply for Sripada National College of Education are eligible to apply for the other National Colleges of Education also in their medium of study if they fulfill required qualification.

#### 7.0 Other Matters Related to Selection:

- 7.1. Selected applicants should be prepared to submit acceptable evidence and originals of certificates to confirm their eligibility for the relevant course at the interview. The opportunity of those who fail to appear in the interview without informing on due date will be filled with other applicants from the same district, based on the order of qualifications. Absentees will not be reconsidered.
- 7.2. It is mandatory to submit the originals of all certificates at the interview. Those who fail to do so will not be considered for selection.
- 7.3. Mental and physical fitness required by an applicant for reaching the expected level in the course and to enter the Teaching Profession will be checked by the interview board at the first interview following the criteria given by the ministry of Education. The interview board will submit their recommendations on whether the applicant possesses the required mental and physical fitness to follow the course and enter the Teaching Profession.
- 7.4. In accordance with paragraph 7.3 the applicants who have completed the qualifications under recruitment criteria and with eligibility as well, will be notified through registered post. Accuracy of the submitted details will be rechecked by an interview board in the registration at the relevant National College of

Education. Only the candidates who are able to reconfirm their eligibility will be recruited to the relevant course at the particular National college of Education. Those who fail to register at the relevant National College of Education within ten (10) working days of the due date will be deprived of the opportunity for admission. The vacancies created thereby, will be filled from the applicants in the data base after calling for an interview according to the performance order, subjected to the provisions stipulated in the recruitment procedure.

- 7.4.1. Hence, it is emphasized that there is no any opportunity to consider appeals of the applicants who are not registered during the stipulated period of time.
  - Specific situations for which an interview board is unable to submit recommendations under 7.3 or 7.4 will be directed to a special board at the Ministry of Education. The report of the special board will be forwarded to the Colleges of Education Board/Secretary to the Ministry of Education for the final decision.
- 7.5. Applicants who are selected to register in the National College of Education after appearing for the first and second interviews are required to appear for a Medical Examination before their admission to the Colleges of Education for the certification of their health condition.
- 7.6. Any applicant can apply for three courses according to order of their preference. Nevertheless, they will be called for interviews only for the courses they complete required qualifications and selection will be made according to the order of performance. A candidate who has been qualified for more than one course will be selected for one course giving priority to the order of applicant's preference for the courses.
- 7.7 After admission to a Course in a National College of Education, permission will not be granted to change such Course/National College of Education even if the applicant is selected for another course. Change of National College of Education/ Course/ Medium of the Course

- under personal grievances will not be allowed after registration in any course in a National College of Education.
- 7.8 If the sufficient number of applicants is not available for a particular course, the applicants will be transferred to the nearest College of Education where the same course is conducted.
- 7.9 The authority of the final decision regarding cancellation of a course for which a required number of teacher vacancies does not exist, determination of the number of student teachers recruited and placement of courses in National Colleges of Education is held by Colleges of Education Board/Secretary to the Ministry of Education.

### 8.0 Persons who are not eligible for applying or admission to the courses.

- 8.1 Those who have already obtained teaching appointments in Government schools, Government aided schools, Government Registered Pirivena or other approved Institutions.
- 8.2 Those who have been selected for a Teaching appointment in a Government school.
- 8.3 Those who are following or who have followed a course in a National College of Education or those who have deserted a course in a National College of Education.
- 8.4 Those who are registered/ are following/followed a degree course under "the privileges of state free Education", registered as an internal student in a State University or State University Institute where G.C.E. (A/L) is the entry requirement. (Students, who withdraw the registration in such institutions after the *Gazette* Notification is published, will not be eligible for applying or admission. Applicants who get registered and withdraw their registration of the above institutions after the *Gazette* Notification is published/appearing in the interview too will not be eligible for admission.)
- 8.5 Student Teachers whose registration in a National college of Education has been terminated on disciplinary grounds/ any other reasons.

8.6 Applicants who have registered the marriage or divorced.

#### 9.0 Conditions applicable for the course:

- 9.1. Duration of a course is three years. This period consists of two year residential institutional training in the National College of Education and one year internship training attached to a school. Attendance of a student teacher should be not less than 90% to enable him/ her to sit for the External Final Examination at the end of the second year.
- 9.2. Every student teacher should pass in the internal continuous assessments and the internal tests held in the first and the second year and the External Final Examination. Except those who follow English medium courses, all those who follow other courses should pass in the English subject at the above examinations.
- 9.3. During the period of two year residential course of study, a student teacher will be provided with meals and lodging facilities to the value of **Rs. 5,000/-** per month for ten(10) months in a year. During the internship year, a monthly allowance of Rs. **5,000/-** will be paid for ten (10) months. Other expenses for personal requirements should be borne by the student teacher.
- 9.4. Student teachers who register in a National college of Education should sign in a bond and agreement with the Secretary to the Ministry of Education to the value of five hundred thousand Rupees (Rs. 500,000.00) for the expenditure made by the government for the course of the applicant and the provision of other infra-structure facilities. If the candidates give up the course within sixty (60) calendar days of registration at the National college of Education, they are allowed to do so after paying the sum spent by the government for the student teacher. If the candidates give up the course after sixty (60) calendar days of registration at the National College of Education, they should pay the whole sum mentioned in the bond and the agreement (Rs.500, 000. 00). A candidate

who does not attend the course work for a period not less than a month without any proper notice, they will be considered deserters and be dismissed from the course after the whole sum mentioned in the bond and the agreement (Rs.500,000.00) is charged.

Student teachers who do not accept the appointment to a government school after the successful completion of the course, should pay the whole sum mentioned in the bond and the agreement (Rs.500, 000. 00) to the government. Those who do not serve the government for five (05) years after successful completion of the course should pay the sum for the remaining period (counted in months) to complete five years. It is calculated as below;

Rs. 500, 000. 00 × remaining number of months to be completed

- 9.4.1 If a candidate gives up the course due to special medical reasons during the course period, the following documentary evidence should be submitted to prove the actual condition of the ailment.
  - Acceptable records of diagnosis, medical checkups and prescriptions.
  - The letter of a government medical officer confirming the inability of the student teacher to continue the course of study any longer.

Management board of the particular National College of Education will their forward observations and recommendations after checking the above documents. Considering the above recommendations, board consisting of officials of the Ministry of Education and a board of medical officers will submit their recommendations for the approval of the Colleges of Education Board/ Secretary to the Ministry of Education. With this approval, the student teacher will be permitted to resign from the course with no imbursement.

- 9.4.2. No student teacher is permitted to go abroad during the course or the period till permanent appointment is given, except when duly resigned from the course.
- 9.5 If a student teacher's registration happened to be terminated on disciplinary grounds or being found out that he/she has submitted false information or for harbouring true information in relation to Para. 8.0 above under 'Persons who are not eligible for applying or admission', the student teacher will be surcharged the whole amount incurred for him/her in the bond (Rs.500, 000.00).
- 9.6 During the period of course a student teacher will not be allowed to follow a course mentioned in section 8.4. If it is found out that a student teacher is following such a course, the sum of the bond and agreement (Rs.500, 000.00) incurred for him/her will be surcharged and the student teacher's registration will be terminated.
- 9.7 It is mandatory that the applicants who are following/have registered for a diploma/higher diploma/professional course in any state higher education institution under the qualifications and conditions mentioned in Para 8.4 of the *Gazette* notification resign from such courses and submit the relevant documents to prove their resignation, to the National College of Education on the day of registration, if selected to a National College of Education. Applicants who fail to do so will not be registered in the National College of Education.
- 9.8 If the student teacher registers marriage during the period of the course or found to have registered the marriage/ divorced before the registration at the National College of Education/ at the time of applying for the course, the studentship will be terminated. Those who get divorced giving various reasons after being found to be married too will not be given studentship.
- 9.9 If the clergy who are recruited under special provisions disrobe within the period of course the sum of the bond and agreement (Rs. 500,000.00) incurred for him/her will

be surcharged and the studentship will be terminated. The clergy of all religions should sign a bond and agreement with the ministry of Education for at least 5 years' service without being disrobed after the completion of the course. If disrobed for any reason before completing the five (05) years, the amount for the remaining number of years (counted in months) should be paid to the government. It is calculated as below:

Rs. 5,00,000.00 × remaining number of months to be completed.

#### NOTE:

- If disrobed during the probation period, such clergy will be surcharged the relevant amount and dismissed.
  - 9.10 If a student teacher fails to exhibit the progress expected in his/her general conduct, attendance, enthusiasm and studies during the study course (inclusive of co-curricular activities), their studentship will be terminated. Likewise, studentship of those who do not reach a satisfactory level in the assessment during the first year of academic training will be terminated. Decision of the Colleges of Education Board/ Secretary to the Ministry of Education shall be final, regarding these matters.
  - 9.11 If any complaints are received in relation to the physical and mental fitness of the student teacher either from the President of the College during the course or from the Principal of the school during the internship period, the student teacher will be referred to a special interview. Final decision will be taken after the submission of that report to the Colleges of Education Board/ Secretary to the Ministry of Education.
  - 9.12. If the student teacher is proved to have engaged him/herself in any action against the code of conduct of National Colleges of Education, Colleges of Education Board/Secretary to the Ministry of Education holds the authority of taking disciplinary action such as suspension to academic classes/extension of the course/ termination of studentship/any other suitable punishment under the recommendation of the

- disciplinary board of the particular National College of Education.
- 9.13. Student teachers are not permitted to follow any other course during weekdays or at weekends outside the college under any circumstances.
- 9.14. If a teacher holding a National Diploma in Teaching, for any reason, resigns from service or resigns and goes abroad within the first five years of service, they should pay the amount for the remaining time (calculated in months) out of the whole amount mentioned in the bond and the agreement (Rs. 500,000.00) to the government. It is calculated as below:

Rs.  $5,00,000.00 \times \text{remaining number of}$  months to be completed.

#### NOTE:

- Those who resign during the first five years of service as mentioned in 9.13 will not be permitted to re-enter service as a holder of National Diploma in Teaching.
- National Diploma Holders are not eligible to claim for the detailed certificate if they have not completed five (05) years active service in a government school.
- National Diploma holders who have not completed the first five (05) year active service and within the probation period are granted no pay leave to go abroad only for study purposes under the provisions of circular 24/2017 of the Secretary to the Ministry of Education, *Gazette* Notification, bond, agreement, rules and regulations of the Establishment Code and the laws in function at the time.
- National Diploma holders who have not completed the first five (05) year active service and have been confirmed in the service are granted no pay leave to go abroad for study/ job purpose under the provisions of circular 24/2017 of the Secretary to the Ministry of Education, *Gazette* Notification, bond, agreement, 16<sup>th</sup> clause of the Chapter XII of the Establishment Code and the laws in function at the time.
  - 9.15. National Diploma in Teaching will be awarded to the student teachers who will successfully complete the course. Course Work and Personality Development (inclusive of compulsory co-curricular activities) will

- be continuously assessed during the period of course and this assessment will form a component of the final evaluation in awarding the National Diploma in Teaching.
- 9.16. The student teachers who successfully complete the National Diploma inTeaching will be given appointments as teachers to the government Schools. They Should agree to serve in any part of the country if no vacancies exist in the relevant district/ province in placement even if they are recruited on district/ province/ national basis. (The Conditions stipulated under the course numbers 45 and 46 are relevant for the courses of Second Language Sinhala/ Tamil) Colleges of Education Board/Secretary to the Ministry of Education holds the authority of placement subjected to the approval of Education Service Committee of the Public Services Commission.
  - 9.16.1. The applicants who are called for interviews for recruitment should appear for the interview only if they agree to the above conditions.
  - 9.16.2. Applicants who follow the course under the above conditions should teach the same subject that they are studying. In addition to that, after completing the National Diploma in Teaching, the applicants who are recruited on district/ provincial/ National basis should sign a bond and agreement with the Secretary to the Ministry of Education stating that they will serve for a minimum period of five (05) years from the date of first appointment as a condition of service in the relevant district/ province which they get their first appointment based on their district/ province of permanent residence or the district named under national basis or any district/ province where the first appointment is given.
- 9.17. If any applicant attempts to get the selected National College of Education changed by the Ministry of Education on medical/ personal reasons, s/he will not be eligible for admission.

- 9.18. Any improper influence made to the relevant officials by the applicant himself/ herself or any other party related to the applicant during the recruitment procedure will be considered a disqualification in recruitment.
- 9.19. All educational and other qualifications in relation to the course applied by the applicant should have been completed on or before the closing date (25. 09. 2020) of applying.
- 9.20. In case of insufficient number of qualified applicants according to the order of performance in district/provincial/ national level for a particular course in a National College of Education to be recruited in the relevant medium from the particular district, the remaining number of vacancies will be filled with the qualified applicants under national basis, giving priority to the courses that have the highest teacher requirement in the education system among the other courses that are conducted in the particular National College of Education. (Priority will be given to the conditions indicated in 'NOTE' – iv under 'Primary Education Course' and 6.3.8 of 6.3 mentioned under 'selection to Sripada National College of Education')

#### 10.0 Instructions for Applying:


 Applications should be submitted with a good understanding of the number recruited for each course on district basis as mentioned in the tables 14.1, 14.2, 14.3 and 14.4 relevant to 14.0 of the gazette notification.

#### 10.1. Special Note;

10.1.1. It is compulsory that every applicant submits his or her application through Online system.

*Note.*– Applications should not be forwarded through registered post.

10.1.2. Online submission of application should be made <u>only</u> in the medium of English. Accordingly, applicants should log into the official website of Ministry of Education to access the relevant online system as mentioned below and apply following the steps given:



- 10.2. The applicant is completely responsible to provide accurate details after reading the instructions in the *Gazette* notification carefully as no opportunity will be provided to amend the information once the application is filled and submitted online according to 10.1.1 above. Especially, the requests to amend the information related to applied course or other information will not be accepted.
- 10.3 Every applicant can apply for three (03) courses in maximum, paying special attention to conditions, qualifications and the number of vacancies mentioned in the *Gazette* notification.
- 10.4 Applying for the same course in two mediums is considered as applying for two (02) courses.

  Those who are bearing priesthood in a religion should apply for the course pertaining to their religion only.
  - e.g. An applicant who applies for the Science Course both in Sinhala and English mediums is considered to have applied for two courses. Then that applicant can apply one more course only.
- 10.5 Numbers relevant for the districts under Para 6.2.1 of 6.2 'Determining the permanent residence' of the *Gazette* notification are mentioned below:
- The number of the permanent resident district of the applicant should be mentioned accurately paying special attention to those district numbers.

- 10.6 It is compulsory that the applicants who apply for the courses of Buddhism, Hinduism, Islam, Catholicism/ Christianity, Physical Education, Western Music must attach scanned copies of the relevant certificates submitted to prove the special qualifications as per the *Gazette* notification as attachments with the application when it is submitted through online system itself.
- 10.7 It is advisable for the applicants to create a personal email address before applying if the applicants do not have a personal email address by the time they submit their applications through online system.
- 10.8 Ministry of Education will bear no responsibility about the inconveniences faced by the applicants who apply without required qualifications mentioned in the *Gazette* Notification for the courses.

- 10.9 Every applicant is provided with the facility to obtain a printed copy of the relevant application after applying through online system. This hard copy (PDF) should be kept with the applicant. All inquiries and appeals should be made with a photocopy of that document. Ministry of Education will bear no responsibility about the inconveniences faced by the applicants due to being inattentive to these instructions.
- 10.10 Applying for a course is not a qualification for the recruitment. Recruitment is made only by considering the vacancies of the district and the conditions mentioned in the *Gazette* Notification. Colleges of Education Board/ Secretary to the Ministry of Education reserves the rights of final decision regarding this.
- 10.11 If any certificate submitted by the applicant is revealed later to be forged or fraudulent, the applicant will be dismissed from the course/service and will further be ineligible for any post in Public Service.
- 11.0 Regarding any problems or specific situations arising with regard to the information and qualifications mentioned in the *Gazette* Notification, the decision of the Colleges of Education Board/ Secretary to the Ministry of Education will be the final decision.
- 12.0 Mentioned in the tables 14.1, 14.2, 14.3 given in the succeeding pages under 14.0 'Admission of Student Teachers to National Colleges of Education based on G.C.E. (A/L) results in 2018 2020' are the numbers to be recruited for each course under each medium from each district to the National Colleges of Education except for Sripada National College of Education and the table 14.4 shows the number to be recruited for each course on plantation district basis under Sinhala , Tamil and English mediums for the Sripada National College of Education.
- 13.0 In the event of any inconsistency between Sinhala and Tamil or English texts of this *Gazette* Notification, the Sinhala text shall prevail.
